

User Agreement

Effective: July, 2026

This User Agreement (“Agreement” or “Contract”) is an agreement between you and STRUCTA LIMITED (“we”, “us”, or “our”) and governs your access to and use of the Safe Cleaner: Secure & Private (“App” or “Service”). We encourage you to read it carefully. If you do not agree to this Contract, do not access or otherwise use any of our Services. If you wish to terminate this Contract at any time, you can do so by no longer accessing or using our Services.

- Minimum Age

(5) copy, reproduce, republish, upload, post, transmit, resell, or distribute in any way, any part of the App.

We reserve the right to limit your use of the Services. We reserve the right to restrict, suspend, or terminate your access to the App if you breach this Contract or the law or are misusing the Services.

- Service Availability

We may change, suspend or discontinue any of our Services. We may also limit the availability of features, content and other information so that they are not available to all users.

- Intellectual Property Rights

We reserve all of our intellectual property rights in the Services. Trademarks and logos used in connection with the Services are the trademarks of their respective owners.
